## Option 2: CATEGORY II (Dues and Assessment Rollover, five hours trail work per person)

Members in this category will pay annual dues (Individual or Family) and will contribute five (5) hours of trail maintenance per voting member prior to October 31 of the membership year. Assessments for trail maintenance for the current year will be collected at the time of membership application. Upon completion of the member's trail maintenance obligation, the pre-paid monetary assessment will be carried over each consecutive year. Failure or inability to fulfill the maintenance obligation (5 hours) will require the member to forfeit the pre-paid monetary assessment. The pre-paid monetary assessment is non-refundable in either case.
